Labor -Contractor shall have on site capabilities of making patterns cutting and installing flat type safety glass. All work for glass installation shall be performed at various County locations and other potential jurisdictions. The Manufacturer’s Publish List Price Sheet shall be used to determine maximum repair time. Labor charges shall not exceed the repair time form the current NAGS calculator, time the contracted hourly rate. Labor rate shall be for on-site time only.
