This Agreement is made and entered into this 4th day of August 2023, by Fauquier County, a political subdivision of the Commonwealth of Virginia, hereinafter referred to as "Owner" and **Thinkblot Behavioral Sciences**, PLLC having its principal place of business at: **1856 Old Reston Ave. Suite 203 Reston**, Va. 20190 hereinafter referred to as "Contractor".

WITNESSETH that the Contractor and the Owner, in consideration of the mutual covenants, promises and agreements herein contained, agree as follows:

SCOPE OF SERVICES: The Contractor shall provide Psychological Testing and Evaluation Services in accordance with the specifications stated to the Owner as set forth in the Contract Documents. Owner primary point of contact for this Contract is the Human Resources Risk Manager.

INSURANCE: By signing this contract, the Contractor agrees they will have the insurance coverage specified on the attached Insurance Checklist at the time the work commences. Additionally, the Contractor certifies that it will maintain all required insurance coverage during the entire term of the contract and that all insurance coverage will be provided by insurance companies authorized to sell insurance in Virginia by the Virginia State Corporation Commission. The Contractor shall furnish the certificate of insurance for the coverage required within five business days of full contract execution, and shall continue to provide compliant insurance certificates throughout the term of the contract.

COMPENSATION: The Owner will pay and the Contractor will accept in full consideration for the performance during the contract term the fees as set forth within the referenced PWC contract and noted herein: \$ 495 per case, for Entry and Special Duty Screening, and \$ 1,950 per case, for Fitness for Duty Evaluation, with payment terms of Net 30 days.

CONTRACT TERM: February 1, 2023 through January 31, 2024 with the option to renew for four (4) additional one (1) year periods by mutual agreement of all parties.

The contract shall consist of and in the event of conflict or ambiguity, shall be interpreted in the following order of priority::

- (1) This signed form inclusive of the Fauquier County Insurance Checklist;
- (2) Fauquier County's General Terms & Conditions & No Crimes Against Children Certification;
- Prince William County Contract 900292-23 dated February 6, 2023, based on Prince William County RFP 700125-23,2 dated November 7, 2022 and the Contractor's Response dated December 9, 2022.

1.0 COST AND PRICING DATA (II.5.B)

Thinkblot is committed to quality service. We do not charge a fee for this communication as it is part of Thinkblot's business practice of providing quality assurance and customer satisfaction.

Fee for Services. Our hourly fee is rarely charged for pre-employment screening services. Please note that our hourly fee for service is included in the unit cost, which in the final analysis makes the service price out for even less per candidate than the per evaluation fee suggests. For example, we routinely discuss cases with the departments we serve, write supplemental reports to account for updated information, and conduct ongoing validation research, all without additional charge. Our standards for care require that these components be a routine part of what is offered so we do not consider such necessities to be an additional expense. Additionally, we do not charge for the time our psychologists spend meeting with your staff for orientation, to provide feedback regarding cases, or orientation to our evaluation approach.

1.1 Compensation Schedule for Services Provided


We will invoice for services on the 1st business day of the calendar month following the month when services were delivered. Payment terms are net thirty days from date of receipt of invoice.

1.2 Conditions that Might Impact Proposed Pricing

Our service prices are firm fixed fees for the first year of the Prince William County Psychological Testing and Evaluation Services contract, but potential adjustments in subsequent contract years may occur. Changes in fees are based on the federal Consumer Price Index for All Urban Consumers and other market values. If the County elects to exercise the option to renew the Contract for an additional one-year period, the Contract price(s) for the subsequent renewal period shall not exceed the Contract price(s) of the previous renewal period increased/decreased by no more than the percentage increase/decrease of the applicable category of the CPI-U section of the Consumer Price Index of the United States Bureau of Labor Statistics for the latest 12 months for which statistics are available." For any cost adjustments, Thinkblot will formally submit a request for change to Prince William County for each one-year contract renewal period. We understand that price increases are not guaranteed and are only granted at the discretion of the assigned Purchasing Agent.

1.3 Detailed Basis for Proposed Pricing of Services

Thinkblot provides a price breakdown for our services for the Prince William County
Psychological Testing and Evaluation Services contract. The following sections detail the
breakdown for pre-employment and special duty screening, as well as Fitness for Duty
evaluations. The service fee for special duty screenings is the same as that for pre-employment



assessment. Overhead for expendable supplies, office space, insurance, and any other applicable expenses are prorated as inclusions in the breakouts that follow.

The proposed pricing represents a modest increase in the cost Prince William County is paying on the current contract for these services. This change reflects increased costs associated with both labor (clinical psychologists and administrative staff) as well as psychological testing materials and ensures that Thinkblot is able to continue to provide the same level of service in the face of a competitive labor market and ongoing inflation. Given that Thinkblot has not requested a price increase since 2019 in spite of these growing market pressures, we hope that the proposed increase in price is perceived as both justifiable and reasonable.


