This letter is being sent as a proposal for the UPS Maintenance at Fauquier County to establish a long term contract using the cooperative procurement clause of the City of Richmond UPS Maintenance Contract # 15000024701. The current agreement will expire on February 28, 2017. The renewal date for your contract is March 1, 2017.

We propose a new service contract under the same terms and conditions as 2016-2017 term. This price includes 2 PM's per year and emergency service, on two Liebert NPower 50kva UPS units and their associated batteries. The new base period of coverage will be from March 1, 2017 to February 28, 2018 and is renewable at the same price through 2018-2020. We have also offered two more 3 year renewal periods through 2026 listed below:
